THE MUNICIPALITY OF CASSELMAN

BY-LAW NO. 2019-XXX

BEING A BY-LAW TO CONFIRM CERTAIN PROCEEDINGS OF COUNCIL OF THE MUNICIPALITY OF CASSELMAN FOR ITS SPECIAL MEETING HELD October 29th, 2019.

WHEREAS under *Section 8 of the Municipal Act, 2001, S.O. 2001, c.25, as amended*, the powers of a municipality shall be interpreted broadly to enable it to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

And WHEREAS under *Section 9 of the Municipal Act, 2001, S.O. 2001, c.25, as amended*, a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

And WHEREAS under *Section 11 (1) of the Municipal Act, 2001, S.O. 2001, c.25, as amended*, a lower-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public, subject to the rules set out in *subsection (4)*;

And WHEREAS it is the desire of the Council of The Municipality of Casselman to confirm proceedings and By-laws.

NOW THEREFORE the Council of The Municipality of Casselman hereby enacts the following as a by-law:

1. That the action of the Council at its meetings held on October 29th, 2019 with respect to each recommendation, by-law and resolution and other action passed and taken or direction given by Council at its said meeting, is, except where the prior approval of the Ontario Municipal Board is required, hereby adopted, ratified and confirmed.
2. That the Mayor, or in his absence the presiding officer of Council, and the proper officials of the municipality are hereby authorized and directed to do all things necessary to give effect to the said action or to obtain approvals where required, and except where otherwise provided, the Mayor, or in his absence the presiding officer, and the Clerk and Deputy Clerk are hereby directed to execute all documents required by statute to be executed by them, as may be necessary in that behalf and to affix the corporate seal of the municipality to all such documents.

READ A FIRST, SECOND and THIRD TIME and FINALLY PASSED this 29th day of October 2019.
