

# SERVICE CONTRACT

### BETWEEN

# This Agreement is made and entered into this October 11 by and between KB Media Corp. ("Service Provider") and The Casselman Municipality ("Client").

WHEREAS, the Client desires to obtain services from the Service Provider, and the Service Provider agrees to provide such services under the terms and conditions set forth in this Agreement.

## NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained, the parties hereto agree as follows:

### 1. Scope of Services

The Service Provider agrees to provide the following services to the Client:

 Selling ad space and naming rights for spaces and infrastructure within The Casselman Municipality.

## 2. Duration of Agreement

This Agreement shall commence on October 11, 2024, and shall continue for a period of three (3) years, terminating on October 11, 2027, unless otherwise terminated in accordance with the provisions of this Agreement.

### 3. Compensation

The Client agrees to compensate the Service Provider as follows:

 A rate of 10% of the value of each ad space rental or naming right opportunity sold by the Service Provider.

## 4. Payment Terms

a. The Service Provider shall invoice the Client for the commission earned at the end of each month. b. The Client shall pay each invoice within thirty (30) days of receipt.

### 5. Termination

Either party may terminate this Agreement by providing thirty (30) days written notice to the other party. In the event of termination, the Service Provider shall be entitled to payment for services rendered up to the effective date of termination.

### 6. Confidentiality

Both parties agree to maintain confidentiality of all information and materials provided under this Agreement and not to disclose any such information to any third party without the prior written consent of the other party.

### 7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario.

### 8. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, representations, or agreements, either written or oral. This Agreement may be amended only by a written document signed by both parties.
