BY-LAW NUMBER: 2019-XXX

BEING A BY-LAW TO AMEND THE SCHEDULE VIII OF BY-LAW 2006-182 REGULATING THE TRAFFIC AND PARKING ON THE HIGHWAYS WITHIN THE MUNICIPALITY OF CASSELMAN AS AMENDED.

NOW THEREFORE the Council of The Municipality of Casselman **ENACTS** as follows:

1. That By-law number 2006-182 is hereby amended by deleting Schedule "VIII" in its entirety and replaced by a new Schedule "VIII" outlined in Schedule "A" hereto attached and forming part of this by-law;

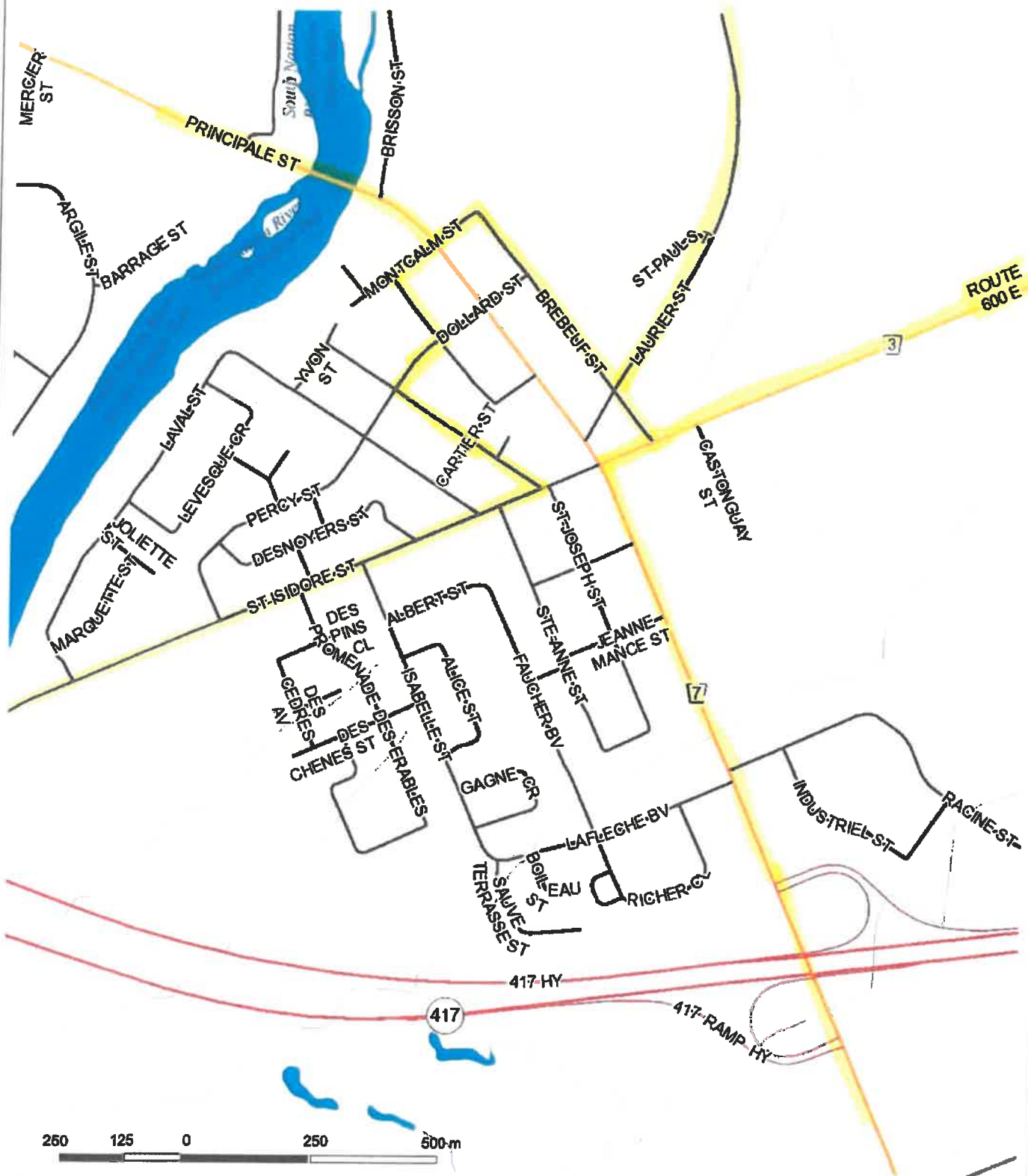
